This twice-annual event brought together entrepreneurs, scientists, venture capitalists, and established corporations within the American and Russian technology communities. The 4th RANIT, which traditionally opens in Philadelphia, highlighted biotechnology and concluded with participation in the world's largest biotechnology exhibition, BIO 2006 in Chicago, and included an important Russia Country Seminar led by MARBC. - In late April 2006, MARBC coordinated the successful American participation in the 7th International Forum "High Technology of the 21st Century" in Moscow. As part of this participation, MARBC President Val Kogan moderated a seminar on "Opportunities for Russian-American Scientific and Technological Cooperation" and presented in a few panels, and MARBC also organized an American mini-pavilion at the event. # The Mid-Atlantic-Russia Business Council and Innovation Philadelphia Host Successful 4th Semi-**Annual Biotechnological Russian-American Innovation Technology Week (RANIT-BIO)**

The Mid-Atlantic – Russia Business Council is pleased to announce the successful closing of the 4th Semi-Annual Russian-American Innovation Technology Week (RANIT). RANIT is a twice-annual event designed to bring together entrepreneurs, scientists, venture capitalists, and established corporations within the American and Russian technology communities. Since its inception, RANIT has become the most significant event in the Mid-Atlantic region devoted to Russian-American technology and business cooperation. The 4th RANIT was organized by the Mid-Atlantic - Russia Business Council (MARBC) and Innovation Philadelphia and was supported by the Baker & McKenzie and Select Greater Philadelphia. The 4th RANIT highlighted biotechnology and concluded with participation in the world's largest biotechnology exhibition, BIO 2006 in Chicago, and included an important Russia Country Seminar led by MARBC. The Russian delegation that took part in the 4th RANIT-BIO consisted of representatives from the best Russian companies in biotechnology and related industries.

RANIT-BIO began in Philadelphia on April 7-8, 2006: Special events at RANIT-BIO in Philadelphia included a welcoming ceremony in the Mayor's Reception Room at Philadelphia City Hall on April 7th, seminars with members of biotechnology associations in the Mid-Atlantic region and venture capital funds specializing in biotechnology, and an "Invention to Venture" workshop. In 2006, RANIT also included events held in celebration of the 300-year anniversary of the birth of Benjamin Franklin, the first American member of the Russian Academy of Sciences.

Two circumstances have made biotechnology cooperation between Russia and the Mid-Atlantic states particularly attractive. First, the Russian government has moved to create a "National Program for the Development of Biotechnology in Russia in 2006-2015". Second, governments in the Mid-Atlantic region have enacted favorable policies that have further enhanced the region's standing as a leader in the field of biotechnology. It is within this context that the Mid-Atlantic Russia - Business Council has made Russian-American scientific and technical cooperation in biotechnology one of its top priorities. MARBC has facilitated American participation in several of the most significant biotechnology conferences and events in Russia, including Biotech World, and the International Congress "Biotechnology: State of the Art and Prospects of Development".

The key and concluding event of the 4th RANIT was BIO 2006, April 9 – 12, 2006, which included the

Russia Country Seminar: As it did in 2005 in Philadelphia, the Mid-Atlantic – Russia Business Council served as the official organizer of the Russian delegation to BIO 2006 in Chicago. BIO is the world's largest and most impressive exhibition and conference for experts in the field of biotechnology. This took place in Chicago at the McCormick Place Convention Center. MARBC again presented Russian biotechnology companies and organized a Russian exposition on the achievements of Russian scientists and manufacturers in biotechnology and related industries. During the first and premier day of the conference on April 9, 2006, dedicated to international programs, MARBC was chosen to conduct a Country Seminar on Russia and a presentation of the Russian biotechnology industry as one of 15 presentations given by the national delegations of countries

# Mid-Atlantic – Russia Business Council Co-hosts Seminar with European Union Ambassador to the United States

The Irish American Business Chamber & Network, the Mid-Atlantic Russia Business Council (MARBC), and other European chambers of commerce in the Greater Philadelphia region co-hosted a breakfast seminar on contemporary issues facing the European Union on Wednesday, May 31, 2006 at the Union League of Philadelphia, . The seminar featured John Bruton, the European Union's ambassador to the United States.

Ambassador Bruton is a former Irish Prime Minister (Taoiseach), who helped transform the Irish economy into the "Celtic Tiger": one of the fastest growing economies in the world. During his time in office (1994-1997), the Irish economy grew at an annual average rate of 8.7%, peaking at 11.1 % in 1997. John Bruton was also deeply involved in the Northern Irish Peace Process leading to the 1998 Good Friday Agreement. While Prime Minister, Ambassador Bruton presided over a successful Irish EU Presidency in 1996 and helped finalize the Stability and Growth Pact, which governs the management of the single European currency: the Euro. He represented the EU at Summit meetings with the President of the United States and with the Prime Ministers of Canada, Japan, China and Korea. Before being appointed Ambassador to the United States, John Bruton served as a leading member of the caucus that drafted the first-ever European Constitution that was signed in Rome on October 29, 2004 and is now before the 25 EU Member States for ratification. He was Vice President of the European People's Party from 1999 to

2005.

The European Union (E.U.) is an unprecedented effort by twenty-five European countries to form a multinational union which addresses both political and economic issues. Member states have relinquished certain policy-making functions to the E.U., which creates uniform policies that apply across all member states. The E.U. is an impressive force in the global economy, producing 31 percent of world's economic output, and it is one of the United States' most important trade partners. Commerce between the United States and the European Union is estimated to have created 7 million jobs in the United States alone.

The seminar included an opportunity for attendees representing local businesses and chambers of commerce to network and was followed by a speech by John Bruton, the European Union's ambassador to the United States. Ambassador Bruton discussed the successes of the EU and the challenges it faces as it continues to expand its membership. Ambassador Bruton made a particular point of noting his appreciation of MARBC's involvement in the program, and included comments about Russia in his presentation. He noted that Russia is of special importance to the European Union as its largest neighbor, and that it is therefore vital for the European and world communities to engage Russia as the country continues to develop and grow.

# The Foreign Policy Research Institute, MARBC, and Other Local Organizations Host Seminar with Franklin Lavin, Under Secretary of Commerce for International Trade

The Foreign Policy Research Institute, the Mid-Atlantic – Russia Business Council (MARBC), the Bucks County International Trade Council, the Chester County Economic Development Council and the World Affairs Council of Greater Valley Forge are pleased to announce the recent successful seminar entitled "International Trade and Globalization" with Franklin L. Lavin, the Under Secretary of Commerce for International Trade. The event was held on Wednesday, June 7, 2006 at the Union League of Philadelphia.

Ambassador Lavin served as the U.S. Ambassador to the Republic of Singapore (2001-2005) and prior to that worked as a banker and venture capitalist in Hong Kong and Singapore, serving in senior banking and management positions at Citibank and Bank of America. During the George H. W. Bush administration, Lavin served as Deputy Assistant Secretary of Commerce for Asia and the Pacific. In that position, he was responsible for commercial policy, assisting companies with market access, and trade negotiations for all of East Asia, except Japan. He has also held staff positions at the White House, the State Department, and the National Security Council.

Ambassador Lavin earned a B.S.F.S. at the School of Foreign Service at Georgetown University, an M.S. in Chinese Language and History, also from Georgetown, an M.A. in International Relations and International Economics from the School of Advanced International Relations at Johns Hopkins University, and an M.B.A. in Finance at the Wharton School at the University of Pennsylvania. Lavin is a Lieutenant Commander in the U.S. Naval Reserves.

# Mid-Atlantic – Russia Business Council Organizes Russian Construction Industry Delegation Visit to the United States

The Mid-Atlantic – Russia Business Council (MARBC) is pleased to announce it successfully organized a delegation of Russian construction industry executives visiting the United States from June 7-14, 2006. The delegation came from Krasnodar Krai, a region in the southwestern corner of Russia, with a goal of learning about the modern techniques and materials used in American construction.

The delegation's visit began in New York, where MARBC organized a special construction industry business program on June 9. Then, delegation members traveled to Philadelphia, where they stayed from June 12-14. While in Philadel-

phia, MARBC arranged for the delegation to meet with Philadelphia city officials. MARBC had also organized individual meetings for the delegation with members of Pennsylvania's building and financial industries on June 12 and 13: delegation members attended a seminar on commercial construction financing, a presentation on sustainable building at architecture firm and will tour a local high-rise construction site.

Since the delegation's visit was also part of the Russian-American Cultural Exchange, MARBC also planned for delegation members to attend a special "Princess and the Patriot" exhibit being held at the losophical Society. # MARBC Successfully Organizes Comprehensive Russian Program at C3 EXPO - 2006

The Mid-Atlantic - Russia Business Council (MARBC) is pleased to announce that it organized the Russian – American Conference and Exhibition on June 28 in conjunction with the Corporate and Channel Computing Expo (C3 EXPO) being held from June 27 – 29, 2006 at the Jacob K. Javits Convention Center in New York City, NY. The program, which was organized by MARBC and sponsored by EPAM and the international law firm of Fox Horan & Camerini LLP, provided opportunities for further business and technology cooperation between U.S. and Russian companies, and included a seminar, panel discussions, and a special Russian Pavilion (booth # 3757).

Since the establishment of the C3 Expo's predecessor, CeBIT America, in 2003, the Russian Conference, organized by the Mid-Atlantic - Russia Business Council, has become an important component of the trade fair's international program. In 2004, CeBIT America was acquired by H.A. Bruno LLC, with programs that originated in CeBIT continuing in the C3 Expo. The 2005 and 2006 C3 Expo was selected by the U.S Department of Commerce as an event for foreign attendees participating in the International Buyers Program.

This year, the main part of the Russian Conference was held on June 28. The program on this day included panels and presentations covering the most promising and pressing issues of Russian-American business and technology cooperation. Welcoming

remarks were given by the Trade Representative and Consul Commercial at the Trade Representation of Russia in the United States, the Deputy Head of the Trade & Economic Mission of Ukraine in the United States, and the Consul General of Belarus in New York.

There was also a "Russian Science & Technology Opportunities for U.S. Business" seminar moderated by Paul Smith, Deputy Chief of Mission (retired) at the US Embassy in Moscow; the seminar highlighted various institutes, scientists, and projects in Russia, and included presentations by U.S. corporations with significant technology transfer collaboration experience in Russia. The presenters were a diverse group, representing organizations ranging from major corporations to small businesses and from research universities to technology associations and foundations. Two executives from Russian outsourcing companies, Eugene Goland of DataArt and Len Erlikh of BridgeQuest, discussed the opportunities for American companies to locate their software development in Russia.

Another important event of the Russian Conference was the panel entitled "Doing Business in Eurasia: Resources and Tips", also moderated by Paul Smith. This panel included speakers from the Embassies and Trade Representations of Eurasian countries, attorneys from Fox Horan & Camerini LLP, and a representative from Vnesheconombank. Attorney Norman Resnicow discussed international contracts and negotiations and intellectual property issues pertinent to the Information Technology indus-

try. Yury Makushin of Vnesheconombank discussed special lending programs available to companies trading with Russia.

A delegation from the Russian Federation, representing companies in the information technology, telecommunications and other technology industries, were present to participate in panel discussions and exhibit the latest advancements in Russian technology for the duration of the C3 EXPO. In addition, a Ukrainian delegation and a Ukrainian technology companies panel took part in the conference and exhibition for the first time. Martijn Eier, General Director of Superweb-Ukraine Company spoke about the technology infrastructure and opportunities for foreign investment in Ukraine.

This year's Russian Conference was organized by the Mid-Atlantic – Russia Business Council and sponsored by EPAM Systems and the international law firm Fox Horan & Camerini LLP. EPAM Systems is ranked number 1 of the "Top 5 to Watch in Central and Eastern Europe" in the annual "Global" Services 100" listing of the world's leading ITO, BPO, and customer care service providers. In addition, Arkadiy Dobkin, the CEO of EPAM Systems, was named one of the Top 25 Most Influential Consultants of the Year by Consulting Magazine. Fox, Horan & Camerini LLP recently signed a cooperation agreement with the Russian Lawyers Guild, Russia's largest legal organization, consisting of law firms, advocacy bureaus, and legal associations

# Mid-Atlantic - Russia Business Council Organizes Important Visit by the Russian Mayors' Delegation to New York and Philadelphia

The Mid-Atlantic - Russia Business Council (MARBC) is pleased to announce that it hosted a delegation consisting of more than thirty local government officials and businessmen, including mayors and heads of administration representing more than 10 cities and regions from across Russia in New York and Philadelphia on July 11-12, 2006. The delegation came to the United States only days before the G8 Summit was held for the first time in Russia and its visit aimed to foster political, cultural and commercial interactions between the United States and Russia. After their visit to Philadelphia, members of the delegation traveled to Washington, D.C. to attend the 50th Annual Sister Cities International Conference.

While in Philadelphia, MARBC organized a welcoming reception for the delegation and a roundtable discussion of regional cooperation and sustainable development issues in the Mayor's Reception Room at Philadelphia City Hall. The program for the event was very intensive, including welcoming remarks, keynote presentations and speeches by both Americans and Russians. As part of the welcoming reception and roundtable discussion, delegation members met with officials from the City of Philadelphia, the Commonwealth of Pennsylvania and the State of Delaware. # **SMART TechTrends 2006**



# Delegation from Leading Russian University to Arrive in Philadelphia in November

Mid-Atlantic Russia Business Council (MARBC) is delighted to announce the arrival in November of a delegation of faculty, students, and administrators from Moscow State University of Economics, Statistics, and Informatics (MESI). The leadership of the delegation includes the first-vice president of the university and the head of the international department. Representatives of diverse aspects of the university from a mathematics professor, to a tennis team captain, to a student theater group will also be part of the delegation. Their visit will be an opportunity to connect with regional universities, not only on an official level, but also through informal contacts among the students. The MESI delegation will participate in a variety of events focused on furthering communication and cooperation between Russian and American universities, including meetings at Temple University, and at other area colleges and universities.

Moscow State University of Economics, Statistics and Informatics (MESI) is one of the leading universities in Russia, offering undergraduate and graduate degree programs in economics, information systems, statistics, management, and business administration. The university prepares highly qualified economists, managers and specialists in IT, computer-sciences, statistics, economics, finance and banking. An innovative, educational, and scientific complex, MESI includes a student population of 10,000 students plus 150,000 regional students participating in the MESI Open and Distant Education system. The university is active in pursuing international co-operation opportunities as a participant of the Bologna process to allow academic mobility among European universities, and was the first Russian University certified according to the European System of Quality Management.

Unsurprisingly for a university with a tradition of international involvement and which has educated more than 2700 foreign students since 1949, MESI has a large alumni population outside Russia. The group is planning a reunion during their visit to Philadelphia with alumni now living in the United States and Canada.

MESI is also particularly active in promoting educational technology, citing innovative educational techniques and the use of modern information technology as central to educational program and important elements in the learning process. MESI was one of the pioneer universities in Russia in the introduction of distance education systems to the study process and maintains its leadership in usage of e-learning technologies. Significant credit for the development and implementation of the e-learning system at MESI belongs to the university's president, Vladimir P. Tikhomirov. Dr. Tikhomirov also serves as president of the Association of Economic Universities of the Russian Federation, the Eurasian Association of Distance Education, and the International Academy of Open Education.

MARBC looks forward to welcoming the MESI delegation in November, and to a productive dialogue between American and Russian students and educators.

MARBC is pleased to announce that it will be hosting the first Russian Beverage Festival in conjunction with the 2007 Pennsylvania Farm Show being held January 6-13, 2007 in Harrisburg, PA. The Pennsylvania Farm Show is the largest indoor agricultural event held in the United States and last year's show attracted over 500,000 visitors. The show attracts approximately 300 commercial exhibitors and more than 10,000 individual exhibitors, who present livestock and agricultural products produced in Pennsylvania. Over the past decade, the show has won numerous awards, including being chosen as one of the top 100 events in America to visit by Event's Business News and receiving the Outstanding Non-Fair Agricultural Event or Program award from the International Association of Fairs & Expositions. The show receives extensive media coverage, particularly on television. The Pennsylvania Cable Network produced 140 hours of coverage, making information about the show easily accessible to 3.3 million households. While the show does emphasize farming, it is designed to appeal to farmers and non-farmers alike. The show includes the Annual Pennsylvania Wine Competition and Pennsylvania Food Court, which is has become a major attraction for those attending the show. As part of the show, the MARBC will be organizing the first ever Russian Beverage Festival in Pennsylvania, highlighting a variety of alcoholic and non-alcoholic beverages produced in Russia. There, MARBC and representatives from Russian beverage companies will be organizing an exhibit about Russian beverages and beverage tastings. Some of the beverages being presented have never been sampled before in the United States.

RANIT, organized by the Mid-Atlantic - Russia Business Council (MARBC), is the most significant event in the Mid-Atlantic region devoted to Russian-American technology and business cooperation. Next year, the 6th RANIT will highlight biotechnology and will conclude with participation in the world's largest biotechnology exhibition, BIO 2007 in Boston. The Russian delegation that will take part in the 6th RANIT-BIO will consist of representatives from the best Russian companies in biotechnology and related industries.

### RANIT-BIO will begin in Philadelphia on May 2-4, 2007

Special events at RANIT-BIO in Philadelphia include a welcoming ceremony in the Mayor's Reception Room at Philadelphia City Hall and seminars with members of biotechnology associations in the Mid-Atlantic region and venture capital funds specializing in biotechnology.

Two circumstances have made biotechnology cooperation between Russia and the Mid-Atlantic states particularly attractive. First, the Russian government has moved to create a "National Program for the Development of Biotechnology in Russia in 2006-2015". Second, governments in the Mid-Atlantic region have enacted favorable policies that have further enhanced the region's standing as a leader in the field of biotechnology. It is within this context that the Mid-Atlantic Russia – Business Council has made Russian-American scientific and technical cooperation in biotechnology one of its top priorities. MARBC has facilitated American participation in several of the most significant biotechnology conferences and events in Russia, including Biotech World, the Moscow International Conference "Biotechnology and Medicine", and the International Congress "Biotechnology: State of the Art and Prospects of Development".

# The key and concluding event of the 6th RANIT will be BIO 2007 in Boston, May 6 - 9, 2007 BIO is the world's largest and most impressive exhibition and conference for experts in the field of biotechnology

At the BIO 2005 exhibition and conference in Philadelphia, Pennsylvania, 1525 expositions by companies, academic institutions, state centers of biotechnology, and other organizations from all 50 states and 56 countries were presented. Within the framework of the exhibition, 180 plenary sessions were organized in which more than 900 speakers shared their expertise. In four days of exhibition, 18,730 specialists took part in BIO. More than 500 journalists from 36 countries covered the exhibition, and 14 press conferences were held.

Russian participation in BIO 2005 in Philadelphia was one of the most important aspects of MARBC's undertaking to build a bridge between the Russian and American biotechnology communities. The Russian business program at BIO 2005 was organized in the context of the Semi-Annual Russian-American Innovation Technology Week (RANIT), and included a Russian mini-pavilion (#2757) and the participation by members of the Russian delegation in various events at BIO 2005. # Mid-Atlantic – Russia Business Council to Participate in XII Moscow Industrial Trade Fair and Moscow Association of Entrepreneurs Round Table

The XII Moscow Industrial Trade Fair, to be held from August 30-September 2, is one of the central events organized around the celebration of City Day in Moscow. The exhibition, directed towards the promotion of national industrial production and technology in the Russian market, has an interregional character. The events promote new business contacts, increased economic linkages, and coordination between the regions and the capital. Within the framework of the exhibition, a large number of business programs will take place with the participation of directors and specialists of the Federal, Moscow city, and Moscow oblast levels of government.

The Moscow Association of Entrepreneurs, longstanding partner of the Mid-Atlantic Russian Business Council, and the oldest association for the protection of private enterprise in Russia, will organize a round table in the business program portion of the trade fair on "Bank Investment in Industry and High Technology: Experience and Challenges." Speakers will address various topics related to attracting investment in scientific projects. A brochure

Guests at this year's round table will include directors of innovation enterprises and organizations participating in the process of developing innovation, financial organizations, scientists, representatives of various levels of legislative and executive power, members of the Moscow Association of Entrepreneurs, and winners from previous years of the innovation competition "Leader in the Field of High Technology." This inno-

vation competition is sponsored annually by the Moscow Entrepreneurs Association and the Government of Moscow, and supported by the MARBC. This year's winners will unveil project displays as part of the round table.

The main part of the business program will be a conference on "Moscow City Procurement" devoted to familiarizing businesses with city procurement procedures, and exchanging information between regional suppliers and the organizers of government competitions and auctions. The Mid-Atlantic- Russia Business (MARBC) recently coordinated the successful American participation in the 7th International Forum "High Technology of the 21st Century" in Moscow from April 24-28, 2006. As part of the American program, MARBC President Val Kogan moderated a seminar entitled "Opportunities for Russian-American scientific-technical cooperation" and John Gallagher, Chairman of the United States Industry Coalition, gave a keynote presentation. Mr. Gallagher presented his organization's goals and the steps the Coalition is taking within the framework of Russian-American technological cooperation. MARBC also organized an American mini-pavilion at the Forum. In addition, along with the Moscow Entrepreneurs Association, MARBC co-organized the innovation competition "Leader in the field of high technology" whose awards ceremony is held as part of the Forum.

MARBC would like to extend an invitation to the 8th International Forum "High Technology of the 21st Century" to be held April 23-27, 2007. As it did this year, MARBC will once again be coordinating American participation in the Forum.

The International Forum takes a two-part form, including both an international exhibition and a business conference. The Ministry of Industry and Energy, the Ministry of Defense, Federal agencies and Services,

the Russian Academy of Science, and government of Moscow all take active parts in the development and direction of the Forum.

The "High Technology of the 21st Century" international exhibition presents technological achievements in the fields of space, radio electronics and communications, information, atomic science, mechanical engineering and metalworking, laser technologies, medicine and biotechnology, ecology, chemistry and new materials, alternative energy and energy- efficient technologies, and safety and security technology. Participants include national and foreign businesses, and organizations specializing in the fields of high technology productions (particularly the defense industry enterprises), as state science centers, academic institutions, financial companies, and investment and venture enterprises.

The Business portion of the Forum includes a series of seminars and round tables, illuminating the problems of innovation activities and financing for scientific projects. Topics related to the attraction of investments into high technology, mechanisms for cooperation among academics and the private sector, intellectual property, improving training systems for industry scientists, problems and

solutions arising from large scale integration, and international cooperation in the field of high technology, will be among those discussed. Russian regions will take an active part in the conference. Round tables and seminars will also be organized on the latest trends in scienceintensive industries, for example: laser technologies, alternative energy technologies, information technology, and others.

Projects are submitted throughout the year and judged in seven categories: information technology and electronics; transport, fuel, and energy; ecology and natural resources; new materials; production technology; and consumer goods. The winners of the competition receive promotional support and advising through the Committee for Innovation Technology, and have the opportunity to exhibit and present their projects at the Forum. # "The Princess & the Patriot" Exhibit Highlights Russian-American Cooperation and Technological Development Through the Lives of Ekaterina Dashkova and Benjamin Franklin

The Mid-Atlantic Russia Business Council (MARBC) is pleased to support the "The Princess & the Patriot" exhibit, currently being held at the Museum of the American Philosophical Society in Philadelphia. The exhibit has been chosen to be part of various MARBC events and conferences during 2006, including hosting visiting delegations from Russia, because it illustrates the long history of Russian-American cooperation and technological development. MARBC encourages those interested in Russian history and the Age of Enlightenment to view the exhibit.

"The Princess and the Patriot" exhibit is being held from February 17 - December 31, 2006 as part of the celebration of the 300th anniversary of the birth of Benjamin Franklin. The exhibit presents Franklin's life in a novel way, emphasizing his role as an Enlightenment thinker and placing him alongside Ekaterina Dashkova, an important figure in 18th century Russia. Though the two came from very different backgrounds, both Franklin and Dashkova were profoundly influenced by the ideas of the Enlightenment that had been developed in Western Europe. Franklin made his mark as a scientist, a printer, and a politician, playing an important role in the development of American democracy. In 1743 he founded the American Philosophical Society, an internationally respected organization dedicated to scholarly pursuits.

During the same era, Princess Ekaterina
Dashkova was making a name for herself in her
native Russia. In 1762, at the age of only 18, she
helped her friend Catherine Alexeyevna
(Catherine the Great) take the Russian throne in a
coup d'etat. Ekaterina was an intellectual who
studied literature and mathematics. She traveled
extensively in Europe and became a friend of
major literary figures including Voltaire and
Diderot. Dashkova achieved further prominence
as an intellectual when she was appointed as
director of the Academy of Russian Language and
the Russian Academy of Sciences.

Franklin and Dashkova met face to face only once – in 1781 in Paris – but each developed a strong respect for the intellect and achievements of the other. In 1789 Franklin nominated Dashkova to become a member of the American Philosophical Society, making her the only female member of the group. In the same year, Franklin was nominated by Dashkova to join the Russian Academy of Sciences, making him its first American member

In April, as a part of the 4th Semi-Annual Russian-American Innovation Technology Week (RANIT)

from April 6-12, 2006, the program included a visit to the exhibit and a Russian musical performance at Benjamin Franklin Hall, which complemented the exhibit. The Russian musical performance featured the group "Talisman," which specializes in performing pieces by female Russian composers who were at the court of Catherine the Great. In the future, MARBC will include the exhibit as a part of the Russian Mayors Delegation's visit to Philadelphia on July 12, 2006, when mayors and local government officials from the Russian Federation will visit the United States. On October 5, 2006, Russian participants of the Russian-American Venture Industry Cooperation Program, who will be attending the Mid-Atlantic Venture Conference, will visit the exhibit. MARBC also plans to include "The Princess and the Patriot" exhibit as a part of the program of the 5th Semi-Annual Russian-American Innovation Technology Week, which will be held from November 13-17, 2006. The 5th Semi-Annual RANIT will include a panel discussion on Franklin and Dashkova and will be followed by a viewing of the exhibit. MARBC would also be pleased to support more Russian musical performances in the future.
